Foundation and Ice Rink Events, and all sponsors of the ice rink establishment and their subsidiaries, affiliates, partners, officers, directors, employees, agents, and volunteers arising out of Participant's use of the ice skating rink and all surrounding areas.

Participants and/or their parent(s) or guardians hereby release and hold harmless ConAgra Foods, Inc, ConAgra Foods Foundation, City of Omaha, Downtown Omaha, Inc., Downtown Omaha, Inc. - Please take care of our ice! No digging into ice with your skates.
